Consent Calendar: Andrew M. moved to accept the consent calendar as presented. Vicki H. seconded. Erin W., Vicki H., and Andrew M. voted in favor. Eric C. and Lisa O. were not present.

Financial Report June: Vicki H. moved to accept the financial report as presented. Andrew M. seconded. Erin W., Vicki H., and Andrew M. voted in favor. Eric C. and Lisa O. were not present.

Old Business

Mural: Nick C. provided an update on the mural progress. The top shelf is completed, and the muralist is finishing up details on the lower three shelves and adding the names of donors to the book spines. Progress is slow but moving forward.
